Florida Division of Emergency Management

State Managed Grant Funded Projects

This appendix is a compilation of lists of grant projects from various grant programs that the Florida Division of Emergency Management (FDEM) manages. These lists serve to provide an update regarding progress of various grant management, as well as proof that FDEM has and continues to manage grants effectively.

HMGP

As discussed in the State Mitigation Strategy Section, the Program Administration by States (PAS) agreement grants FDEM authority to manage the HMGP program in Florida. Responsibilities include reviewing project applications, completing Benefit-Cost Analyses, approving scope-of-work modifications, and moving funds between applicable projects. The PAS program gives Florida increased control and oversight over their projects and shortens the standard 24-month grant obligation timeline.

The HMGP table in this appendix reflects all the HMGP grant projects that have been awarded between FY 2013 and FY 2017. If the project has been closed, it is indicated by the closure date.

After the HMGP table, is a chart showing all the HMGP grants that FDEM has received between 1993 and 2017. This chart details the name of the disaster and the status of the grant. Several grants have been closed which is indicated with the date of closure. Those grants that are still open are listed as such.

Non-Disaster Grants

This table shows the Non-Disaster grants that FDEM has been awarded between FY 2013 and FY 2017. This includes grants from the Flood Mitigation Assistance (FMA) grant program and the Pre-Disaster Mitigation (PDM) program. If the project has been closed, it is indicated with the closure date.

HLMP

This table shows the Hurricane Loss Mitigation Program (HLMP) grants that have been funded between FY 2013 and FY 2017. This grant program is funded through a state funding source and the program changed names from the Residential Construction Mitigation Program (RCMP) to the HLMP, which is reflected in the project names within this table. The grant status is indicated by either the closure date or is blank, which means it is still open.
