BACKGROUND AND OVERVIEW

The **Advanced Professional Series (APS)** is a nationally recognized training pathway developed by FEMA and adopted by the **Florida Division of Emergency Management (FDEM)** to enhance the professional development of emergency management practitioners.

GOAL:

The APS program is designed to build the practical knowledge and management skills required to effectively lead local, state, and tribal emergency management programs. It bridges foundational emergency management principles with advanced, scenario-based learning.

PROGRAM DELIVERY:

APS courses are delivered through:

- **State Emergency Management Agencies (including FDEM)**
- **The National Domestic Preparedness Consortium (NDPC)**
- **The FEMA Emergency Management Institute (EMI)**

Learners may complete APS courses in-person, virtually, or in a hybrid format, as scheduled within SERT TRAC at <https://trac.floridadisaster.org/trac/loginform.aspx>.

TARGET AUDIENCE

The APS program is intended for:

- Local and state emergency management professionals
- Emergency coordinators from partner agencies and jurisdictions
- Individuals seeking advanced leadership and coordination skills in disaster preparedness, response, recovery, and mitigation

PROGRAM REQUIREMENTS

To earn the Advanced Professional Series Certificate of Completion, students must complete:

- **Five (5) Required Core Courses**, and
- **Five (5) Elective Courses** selected from the approved APS elective list

All course completions must be documented through certificates of completion and verified by the State Training Coordinator.

CURRENT PROCESS (SERT TRAC)

TRANSITION TO GENIUS SOLUTIONS (DIGITAL CERTIFICATE)

As FDEM transitions from SERT TRAC to the new FDEM Training Platform, the APS certificate process will become fully digital.

- Students will no longer need to manually send email submissions.
- Course completions will be automatically tracked in the new FDEM Training Platform.
- Upon meeting program requirements, a digital certificate will be issued electronically by FDEM.
