


Cases in Florida residents per day for the past 2 weeks


Median age of cases by day

Number of Florida residents tested per day



The percent of positive results ranged from 10.70% to 16.29% over the past 2 weeks and was 10.70% yesterday.



A person is only counted once for each day they are tested, regardless of whether multiple specimens are tested or multiple results are received. If a person has a positive specimen and a negative specimen in the same day, only the positive result is counted.



Percent positivity for new cases in Florida residents

The percent of positive results ranged from 8.08% to 11.90% over the past 2 weeks and was 8.08% yesterday.

This percent is the number of people who test PCR- or antigen-positive for the first time divided by all the people tested that day, excluding people who have previously tested positive.








Deaths in Florida residents by date of death





