# Flood Mitigation Assistance and Pre-Disaster Mitigation Grant Programs Subapplication Process

Fully eligible and completed subapplications must be submitted to the Florida Division of Emergency Management (FDEM) through the eGrants system. FDEM will forward eligible subapplications to FEMA for funding consideration. All subapplications must be submitted to FDEM via the eGrants application system on or before the announced deadline.

# **eGrants Access-Training and Registration**

### **eGrants Training for the Subapplicant**

eGrants stream-lines the application process by providing governmental units with the ability to apply for and manage subgrant applications over the Internet. Training is available through an interactive computer based course designed to provide local and Native American Tribal governments with basic knowledge about using the web-based Mitigation Electronic Grants (eGrants) System.

This course is designed to allow the individual to take it in its entirety or to focus on specific aspects of the eGrants System. The course examines registering for access to the eGrants System; creating, completing and submitting subapplications to FDEM for forwarding to FEMA; and managing approved subapplications. ## **eGrants Registration for Subapplicants**

#### **Who Should Register**

- Eligible subapplicants should designate a representative(s) to create and edit project subapplications; and/or
- Eligible subapplicants should designate a representative(s) to sign and submit the project subapplication. This representative may be the chief elected official or chief administrative official of the local or Native American Tribal government, or his/her designee.

## **How to Register**

- 1. Click on "New Non-PIV User?" link to register.
- 2. Personal Information is entered on the next several screens; Click on Submit when requested at the end of each page.

- 3. A new window will appear with the message Click here to request new privileges.
- 4. Click on Mitigation eGrants. The next screen will ask for an "ACCESS ID". Enter S12 and submit.
- 5. The next screen confirms that registration is successful and you will see the message "Your request is being processed". This means that the request has been placed in the eGrants system approval queue.

- 6. Once the registration is complete, you can begin to work on the subapplication.

  For FMA projects FY2018 FMA Subapplicant Name Project Name

  For PDM projects FY2018 PDM Subapplicant Name Project Name
- 8. Upon completion of the subapplication, please notify the Project Manager for your area (see attached FMA Grant Program Territorial Assignments Map for the contact information for the project manager where the project is located).
